

Film Falmouth Cape Cod

Online Film Production Guide Application Policy

Falmouth Production Guide lists Falmouth, Cape Cod and surrounding areas film industry vendors and crew members. Listings for non-Falmouth Chamber members expire December 31st of each year regardless of when the application was submitted and when the information was uploaded to appear live online. Listings for Falmouth Chamber members expire at the expiration date of Falmouth Chamber membership.

Applications must meet the following criteria:

For All Listings, Crew & Vendors:

1. Applicants must submit the most recent application (available at filmfalmouth.com.)
2. Applicants must complete and sign the application for consideration.
3. Applicants may only have one listing per category.
4. A company name may only appear once in a category.
5. Applicants may have a maximum of three listings in three different categories.
6. All applicants must have their Massachusetts address on the application whether or not they want it to appear online.
7. All applicants must have at least one in-state contact number listed.
8. Only in-state checks and in-state money orders are accepted for payment.

(Note: If a check or money order is mailed from out-of-state, this may delay the acceptance of your application as your Massachusetts affiliation must be verified.)

Additional Criteria for Crew Listings (Individuals):

1. Applicant's primary residence must be in Massachusetts, preferably on Cape Cod.
2. Only one name may be displayed in each crew listing.

The Falmouth Film Office of the Falmouth Chamber of Commerce reserves the right to verify membership to any union, guild or association as listed on the application and to inquire about membership residency status by contacting the said affiliation provided by the applicant.

Additional Criteria for Vendor Listings (Companies):

1. Vendors listing their company must be registered with the Massachusetts State Tax & Revenue department.
2. Vendors must provide a state registration number that verifies that the business is based in Massachusetts and pays in-state taxes (i.e. a MA tax id number, social security number for Sole Proprietors, a copy of a MA business license, a MA real estate license number.) Certain businesses require MA licenses and this will depend upon the category in which one requests to be listed. This information will not appear online.

The listings that appear in the Falmouth Cape Cod Production Guide are paid advertising or a benefit of membership with the Falmouth Chamber of Commerce. Neither the Town of Falmouth nor the Falmouth Film Office or the Falmouth Chamber of Commerce warrants the truth or accuracy of any of the statements contained in the online listings. The Falmouth Film Office reserves the right to remove listings from the site for non-payment and in the event a listing contains false or misleading information and reserves the right to remove listings that are not immediately corrected by the listing entity upon written notice from the Falmouth Film Office.
